








Marketing Support for Registration of Crafts on e-platform

After login, select My Incentive from the left side menu. Click on Add Incentive.




After clicking on Add Incentive, Add Incentive pop-up will appear.



Select Department of Handloom and Handicraft DolC in **Department** field and on Incentive Name, check the **Marketing Support for Registration of Crafts on e-platform** and click on the **Submit** button.



Now, the following form will open which you have to fill to proceed:



Name of Applicant - Enter the name of the applicant here.

D/O, S/O, W/O - Mention here the Daughter of/ Son of/ Wife of Name.

Residential Address - Enter the Applicant's address here.

Category - Select the category of the applicant whether he/she is SC, ST, OBC or General.

Date of Birth - Enter the Date of Birth here.

Age- Enter your age here.

District- Select the district.

Assistant Director- Select here the assistant director.

IFSC Code- Enter the IFSC code of bank. In case you don't know the IFSC Code for your bank, click on the Find Bank button to fetch the IFSC Code.

Bank Name- Enter the bank name here.

Account Number- Enter here your Bank's Account Number.

Aadhaar Number- Enter the aadhaar number.

Contact Number- Enter the contact number here.

Name of the Block- Enter here the name of the block.

Constituency Name- Enter here the constituency name.

Education Qualifucation - Enter here the educational qualification.
