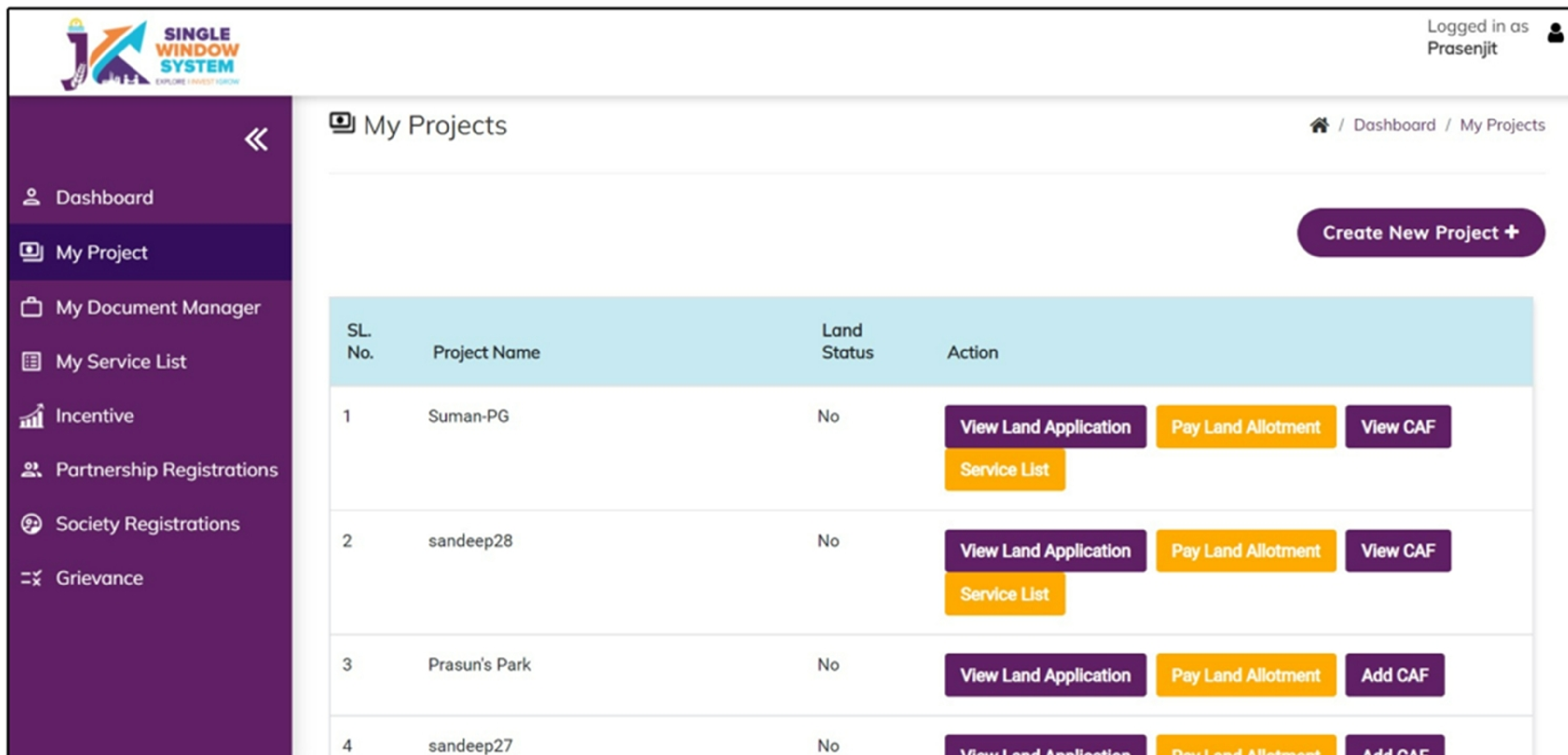

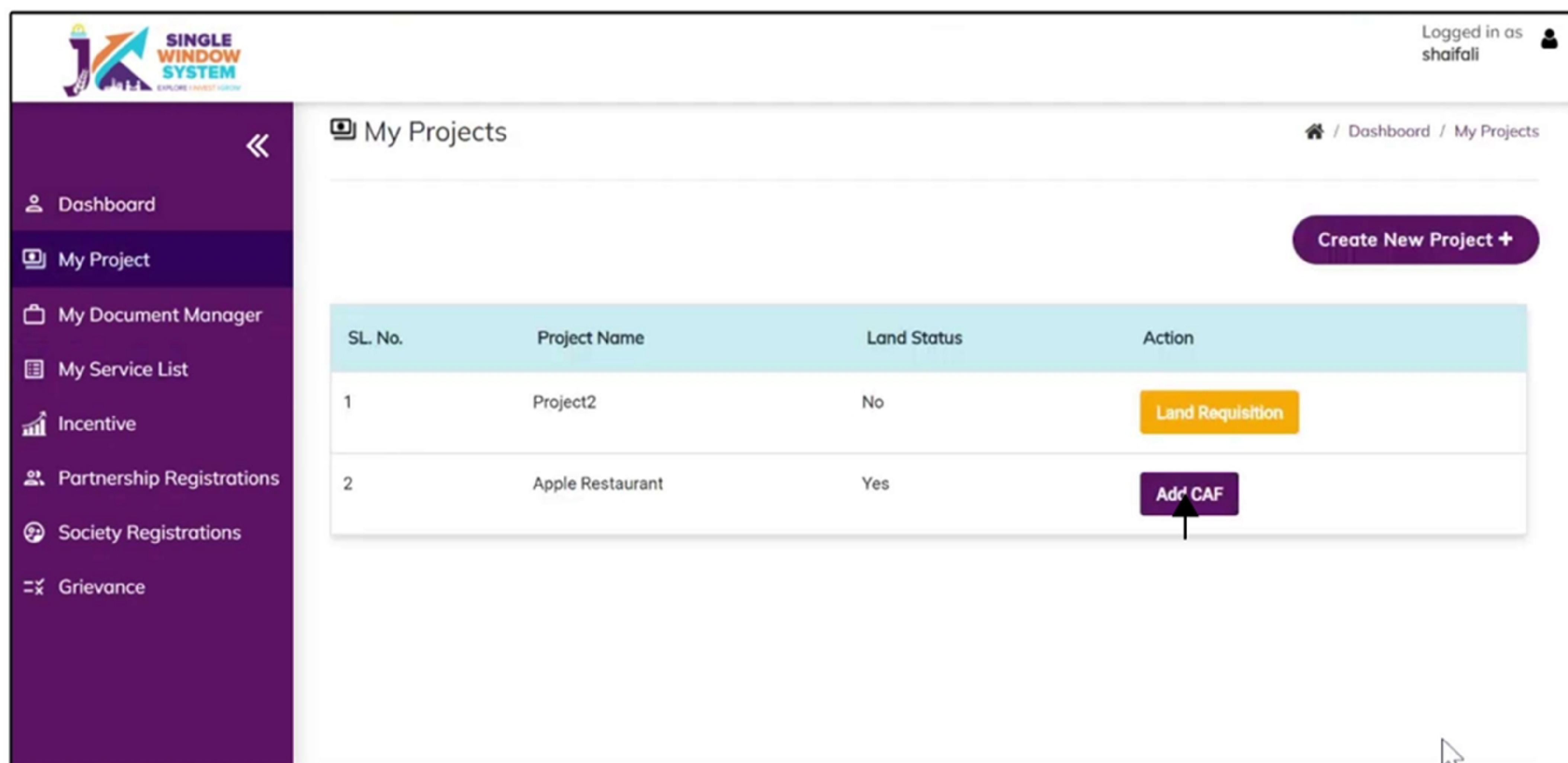
After login into the website, select My Project from the side menu. Then following page will appear. Click on the Create New Project to create your project.


# Registration under Shops and Establishment Act

Through this user manual, explore the intuitive interface of the Single Window System, where the registration process is designed to be user-friendly, transparent, and in alignment with the regulatory framework.

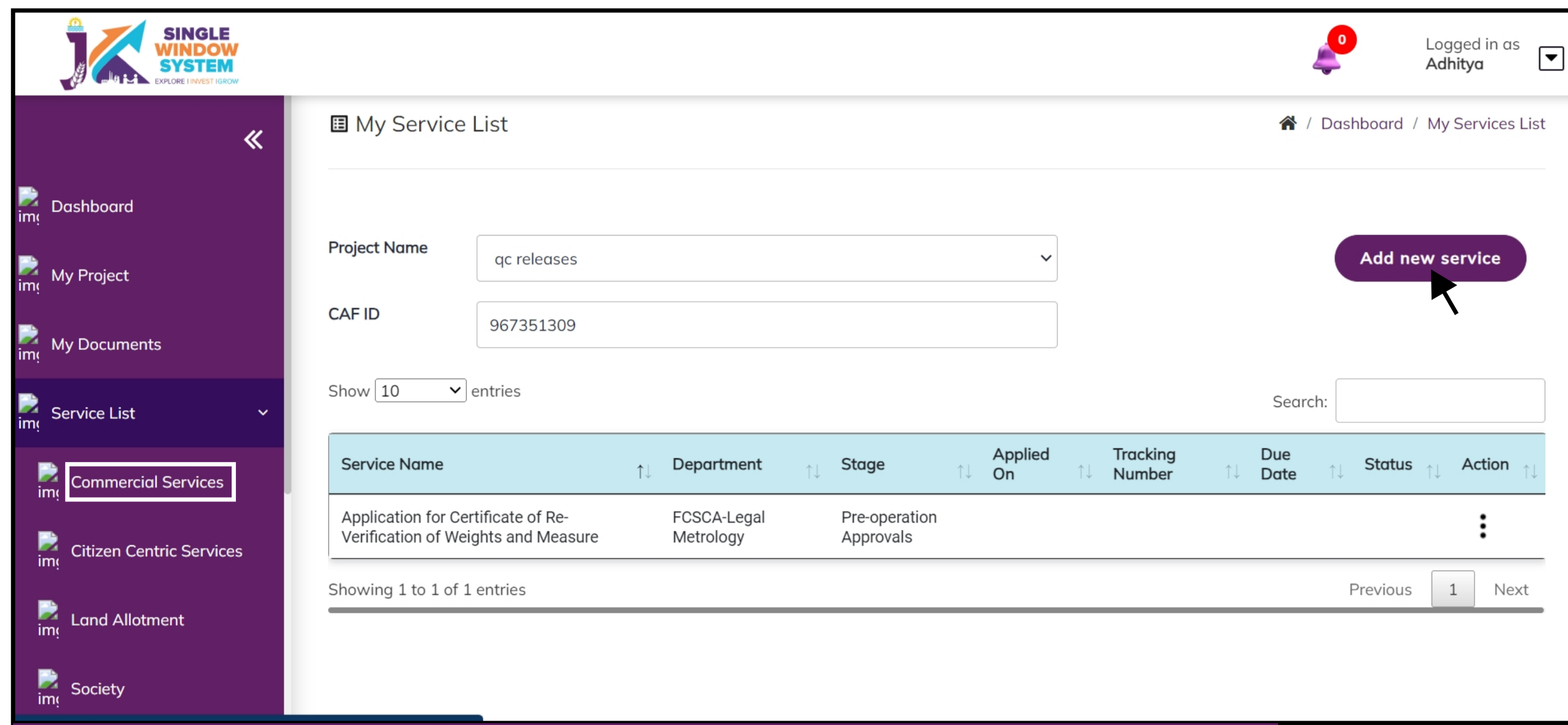

**Log in** using your provided credentials. If you do not have an account yet, you will need to register to avail of our services. For registration assistance, please refer to our registration guide or contact our support team.

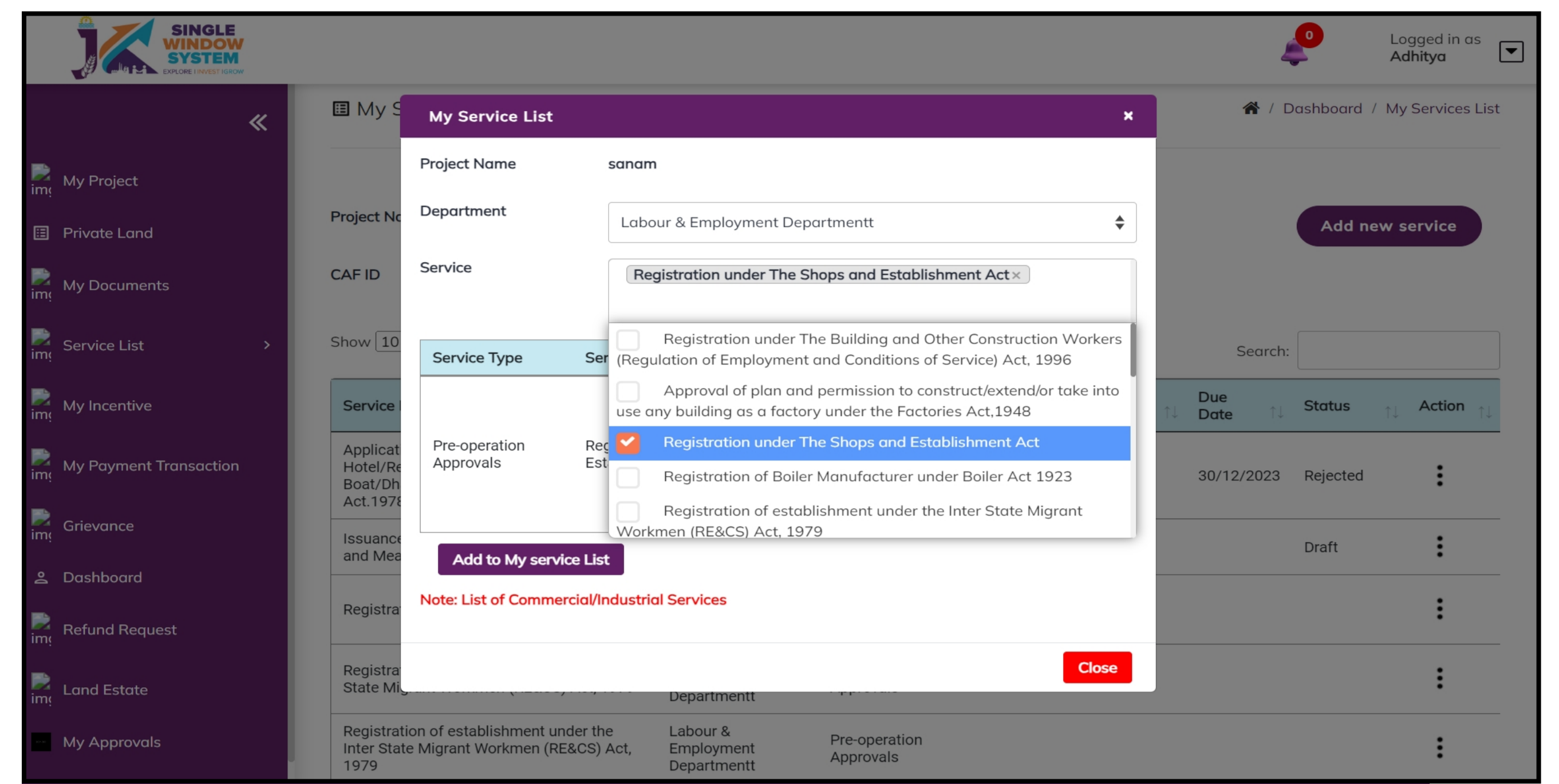

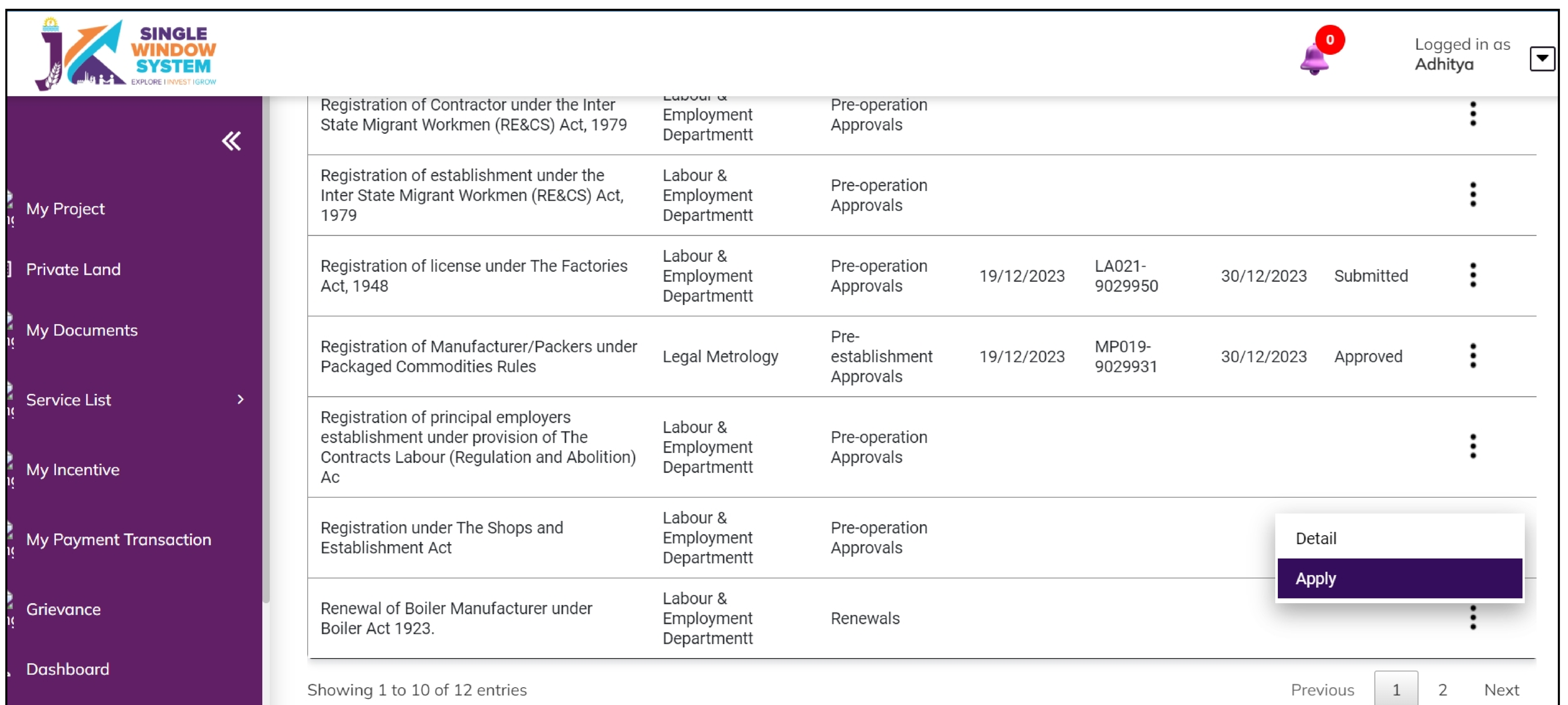


1. Select Service List > Commercial Services from the left side menu and then click on Add New Service.

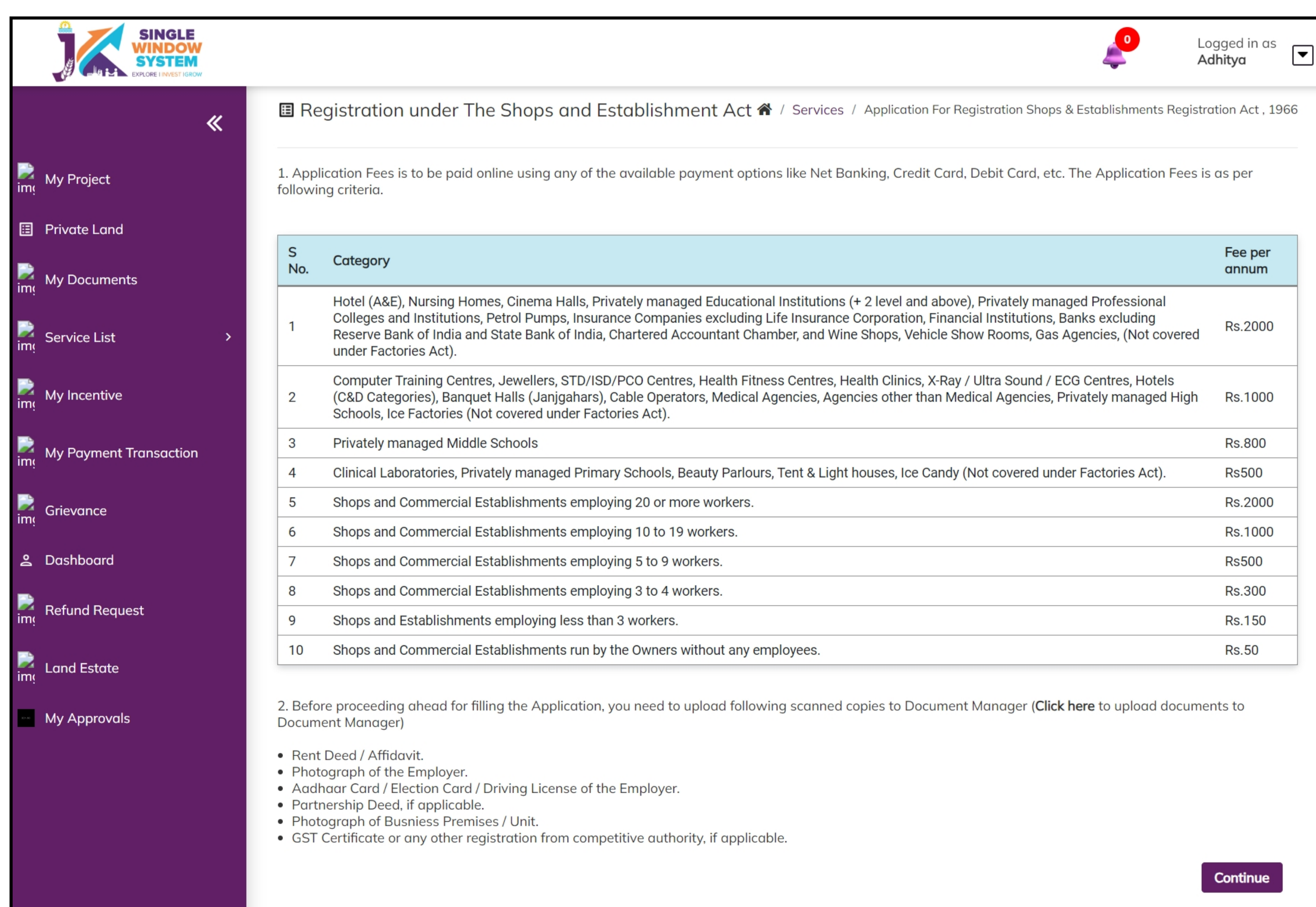


2. Select Labour & Employment Department from Department drop-down list and then select service to add.

## Number of Employees-

In the "Number of Employees" section, you are required to furnish detailed information about the composition of your workforce, categorized into "Local" and "Migrant" employees. For each category, input the number of male, female, and transgender employees, along with the corresponding totals. This granular breakdown ensures a comprehensive representation of your workforce, contributing to accurate statistical reporting and compliance with regulatory standards. The "Total Value" column consolidates the overall count, offering a holistic view of your entire workforce, inclusive of both local and migrant employees. This data not only aids in regulatory compliance but also provides valuable insights into the diversity and gender distribution within your establishment. Enter the information diligently, as it plays a crucial role in maintaining transparency and adherence to employment regulations.

**Name of the day of the week on which the weekly holiday will be observed-** In this section, you are required to choose the specific day for the weekly holiday. This applies specifically to shops and commercial establishments. Choose the day from the dropdown menu on which your establishment observes its weekly holiday. Options typically include days of the week such as Sunday, Monday, etc. This selection is crucial for compliance with labor regulations and ensures clarity for both employees and customers regarding the designated weekly off day.

## Documents :

In the Documents section select the documents from the drop down menu. Select all the documents accordingly. If the document is not in the dropdown then you can add that document in document manager or you can click on "**Upload Documents**" and your document will be then showing under the dropdown menu. After filling all the required fields, read the declaration carefully and tick the checkbox of declaration. Now, click on the **Continue** button to proceed.

Now, you can view all the filled details. To change/modify any details click on the Edit button, else click on the Continue button. Now the payment page will appear. After the successful payment the process is completed.
